<p>Documents</p>	<p>For entitlements to reduced registration fees, the owner of the animal must produce proof of sterilisation, microchip, implant, membership of approved association, obedience papers, breeding license, statutory declaration or tax return for proof of working dog status.</p>	<p>Micro-chipping</p>	<p>As from 1st May 2007, all new applications to register a dog/cat will not be accepted unless the dog/cat has been implanted with a microchip (of which proof must be provided). This includes dogs/cats moving into the municipality from another Council.</p>
		<p>Replacement tags</p>	<p>Replacement registration tags can be purchased for \$5 at the Council Offices at 1 Bridge Street East, Benalla</p>
		<p>Privacy statement</p>	<p>The personal information provided and/or requested on this form is being collected by the Council for Animal Registration purposes. It will be used solely by the Council for that primary purpose or directly related purposes. Owners may apply to the Council for access to or amendment of the information.</p>
