#### Cr Firth / Cr Davis:

That Council, acting under clause 3 of Schedule 10 of the *Local Government Act* 1989 (Act):

- 1. Having followed all the required statutory procedures pursuant to sections 207A and 223 of the Act, and being of the opinion that the government roads abutting Nelson Road, Winton North, being the land shown marked as 'lot 1' on each of the plans attached to this report as Appendix 1 (Roads), are not reasonably required for public use for the reasons set out in this report, resolves that the Roads be discontinued:
- 2. Directs that a notice pursuant to the provisions of clause 3(a) of Schedule 10 of the Act is to be published in the *Victoria Government Gazette*; and
- 3. Directs that any easements, rights or interests required to be created or saved over the Roads by any authority be done so and not be affected by the discontinuance of the Roads.
