4.1 Benalla Indoor Recreation Centre Redevelopment Project

PURPOSE OF REPORT

The report presents for the Council's consideration a preferred site for the *Benalla Indoor Recreation Centre Redevelopment* project.

BACKGROUND

On 23 May 2023, State Member for Northern Victoria Jaclyn Symes announced \$15 Million of funding for the redevelopment of the Benalla Indoor Recreation Centre (BIRC).

The Council, at its meeting on 11 October 2023, resolved to award the Benalla Indoor Recreation Centre Redevelopment Architectural Services Contract to architects Brand & Co Pty Ltd.

The Council, at its meeting on 13 December 2023, adopted the *Benalla Indoor Recreation* Centre Redevelopment Project Community Engagement Plan and placed the *Benalla Indoor Recreation Centre Redevelopment Project* on public exhibition.

Community engagement took place between 14 December 2023 and 9 February 2024. The focus of the first stage of community engagement was to determine community's preferred site for the redevelopment.

The three sites considered were:

- current Benalla Indoor Recreation Centre Ackerly Avenue, Benalla.
- disused Benalla P-12 College Barkly Street Campus 41-55 Barkly Street; Benalla.
- Churchill Recreation Reserve 103 Waller Street, Benalla

On 10 April 2024 community engagement results were presented to the Council's Finance and Planning Committee.

Seven hundred and sixteen responses were received revealing varying preferences among community members with the Benalla P-12 College Barkly Street Campus emerging as the most favored site.

Submissions were formally considered at the Finance and Planning Committee meeting on 10 April 2024 were the Council resolved:

That the submissions be taken into consideration to determine the location of the redevelopment of the Benalla Indoor Recreation Centre.

DISCUSSION

The BIRC project provides the Council with an opportunity to enhance community assets with a modern and purpose-built facility to complement existing community infrastructure.

Site Assessments

Site assessments were undertaken by Brand & Co Architects based on information derived from site visits and other site information. Each site was considered using a detailed list of criteria resulting in the site assessments detailed below, which were made available to the community as part of the engagement program.

Ackerly Avenue

The current Benalla Indoor Recreation Centre site faces significant constraints, including limited space for expansion, flooding issues, and aging infrastructure. These issues potentially render this location unsuitable for substantial redevelopment.

It is proposed that as part of the overall BIRC Redevelopment project, an assessment of current and potential future uses of the site be undertaken taking into consideration these constraints.

Benalla P-12 College Barkly Street Campus

The Benalla P-12 College Barkly Street Campus offers potential for redevelopment, albeit with associated risks, including heritage considerations and unknown complexities surrounding utilities and existing buildings.

The Barkly Street education precinct sits on multiple titles. In discussions with the Department of Education, one of the larger titles of land has been identified as a suitable location for the BIRC project.

While the size of the identified land potentially restricts the project to two full size multi-use sports courts; one smaller multi-use sports court; and several smaller courts and multi-use zones, there is adjacent land potentially available for future expansion.

A existing conditions plan of the proposed site is attached as **Appendix 1**.

Churchill Recreation Reserve

The Churchill Recreation Reserve is suitable for accommodating a variety of sports facilities. However, a potential risk has been identified with some parts of the site known to have been used as a rubbish tip.

Further investigations are recommended to understand the site's risks and conditions fully. It is proposed that results from these investigations and an associated community engagement activity be used to develop a Churchill Recreation Reserve Masterplan to maximise use of this important recreation facility located in a growth area of Benalla.

Summary

Community engagement has identified the Benalla P-12 College Barkly Street Campus as the preferred site for the BIRC redevelopment project. While the site has challenges to overcome, these may be reduced as discussions with the Department of Education progress.

The whole Barkly Street site has potential to be developed into a community precinct and it is recommended that a masterplan be developed for the entire site while the BIRC Redevelopment project proceeds.

Benalla Indoor Recreation Centre Project Steering Committee

To oversee the progress of the BIRC Redevelopment project it is recommended a *Benalla Indoor Recreation Centre Project Steering Committee* be established with representation from the Council, user groups and community members.

A draft Benalla Indoor Recreation Centre Project Steering Committee Terms of Reference is attached as **Appendix 2**.

The purpose of the steering committee is to:

- Ensure project success and support delivery of the Benalla Indoor Recreation Centre Redevelopment Project to the community.
- Ensure the design of the *Benalla Indoor Recreation Centre Redevelopment Project* is inclusive and fit for purpose.
- Represent the community and provide guidance and direction based on the community's needs.

The steering committee will have the following duties and functions:

- Provide advice, directions and requirements to help with the design and quality of the Benalla Indoor Recreation Centre Redevelopment Project.
- Ensure the project is achievable and in line with community expectations.
- Review, endorse and reject, recommend, shape, and influence the outcomes and scope of the design.
- Gain and provide feedback to and from community stakeholders.
- Promote collaboration, research and input from the broader community and all stakeholders.
- Make recommendations to the Benalla Indoor Recreation Centre Project Control Group.
- Adhere to Councils code of conduct and values.

It is proposed membership of the *Benalla Indoor Recreation Centre Project Steering Committee* be comprised of the following members:

- Up to two Councillor representatives.
- Up to two community members.
- Up to three Council Officers (Community Development Coordinator, Project Manager and Open Spaces Coordinator).
- Representatives from Hume Region Community Infrastructure, Place, Sport and Recreation Victoria and Basketball Victoria.
- The President of Benalla Basketball Association.
- The Chair of the Benalla Indoor Recreation Centre Committee of Management.

Members of the committee will be appointed for the term of the project.

Once the terms of reference are approved, the Council will appoint Councillor representatives and invite internal and external stakeholder representatives to join the committee.

COMMUNITY ENGAGEMENT

Benalla Indoor Recreation Centre Redevelopment Project

The Benalla Indoor Recreation Centre Redevelopment Project Community Engagement Plan was adopted by Council at its meeting on 13 December 2023.

Community engagement on the *Benalla Indoor Recreation Centre Redevelopment Project* commenced on 14 December 2023 to 9 February 2024. The focus of the first stage of community engagement was to determine the Benalla Rural City communities preferred site for the redevelopment.

Community Engagement was undertaken at the 'Involve' level under the International Association for Public Participation's IAP2 public participation spectrum as detailed in the Benalla Indoor Recreation Centre Redevelopment Project Community Engagement Plan.

The results of the community feedback surveys are:

- Most preferred site: Benalla P-12 College Barkly Street site received 51 percent of votes.
- the current Benalla Indoor Recreation Centre at Ackerly Avenue received 24.5 percent of votes and Churchill Recreation Reserve received 24.5 percent of votes.
- Least preferred site: the current Benalla Indoor Recreation Centre at Ackerly Avenue received 41 percent of votes, Churchill Recreation Reserve received 41 percent of votes and Benalla P-12 College Barkly Street site received 18 percent of votes.

Further community engagement on the *Benalla Indoor Recreation Centre (BIRC)*Redevelopment project for the design of the project will be presented to the Council and available for community feedback at a future date.

Benalla Indoor Recreation Centre Project Steering Committee

In accordance with the Council's *Community Engagement Policy*, it is proposed that community engagement on the establishment of the *Benalla Indoor Recreation Centre Project Steering Committee* be undertaken at the *'Inform'* level under the International Association for Public Participation's IAP2 public participation spectrum.

FINANCIAL IMPLICATIONS

The Victorian State Government has allocated \$15 million towards the *Benalla Indoor Recreation Centre (BIRC) Redevelopment project*.

The following allocations have been proposed for inclusion in the proposed *Benalla Rural City Council 2024/25 Budget*:

- \$100,000 to develop Churchill Recreation Reserve masterplan
- \$100,000 to develop a Barkly Street Community Precinct masterplan.

LEGISLATIVE AND STATUTORY IMPLICATIONS

It is considered that the report is consistent with the *Charter of Human Rights and Responsibilities Act 2006* and *Gender Equality Act 2020*.

CONCLUSION

It is proposed that the Council provide in-principle support for the disused Benalla P-12 College Barkly Street Campus as the preferred location for the *Benalla Indoor Recreation Centre Redevelopment* project.

If the Council resolves to endorse Barkly Street as the preferred site for the BIRC redevelopment, a formal proposal to the Department of Education (DoE) will be prepared for its consideration. A report on the DoE's response will be presented to the Council in due course.

- 1. That the Council give in principle support for the Benalla P-12 College Barkly Street Campus as the preferred site location for the Benalla Indoor Recreation Centre Redevelopment project.
- That the Chief Executive Officer negotiate with the Department of Education for the Council to acquire crown land at 51-54 Barkly Street, Benalla.

 - Basketball Victoria
 - President Benalla Basketball Association
 - Chair of the Benalla Indoor Recreation Centre Committee of Management.

1. Purpose

The purpose of the Benalla Indoor Recreation Centre Project Steering Committee is to:

- Ensure project success and support delivery of the Benalla Indoor Recreation Centre Redevelopment Project to the community.
- Ensure the design of the *Benalla Indoor Recreation Centre Redevelopment Project* is inclusive and fit for purpose.
- Represent the community and provide guidance and direction based on the community's needs.

2. Duties and Functions

The Benalla Indoor Recreation Centre Project Steering Committee has the following duties and functions:

- Provide advice, directions and requirements to help with the design and quality of the Benalla Indoor Recreation Centre Redevelopment Project.
- Ensure the project is achievable and in line with community expectations.
- Review, endorse and reject, recommend, shape, and influence the outcomes and scope of the design.
- Gain and provide feedback to and from community stakeholders.
- Promote collaboration, research and input from the broader community and all stakeholders.
- Make recommendations to the Benalla Indoor Recreation Centre Project Control Group.
- Adhere to Councils code of conduct and values.

3. Delegations

The Committee has no delegated power to act on behalf of the Council or commit the Council to any expenditure.

4. Membership

- 4.1 Membership of the Benalla Indoor Recreation Centre Project Steering Committee shall be comprised of the following members:
 - Up to two Councilor representatives.
 - Up to two Community member representatives.
 - Up to three Council Officers (Community Development Coordinator, Project Manager and Open Spaces Coordinator).
 - Representatives from Hume Region Community Infrastructure, Place, Sport and Recreation Victoria and Basketball Victoria.
 - The President of Benalla Basketball Association.
 - The chair of the Benalla Indoor Recreation Centre Committee.
- 4.2 The Council will appoint Councillors representatives and invite internal and external stakeholder representatives to join the committee.
- 4.3 The members of Committee are appointed for the term of the project.
- 4.4 Meetings of the Committee will be chaired by the Project Manager.
- 4.5 The committee may seek the involvement of additional members with interests and expertise relevant to the task at hand.
- 4.6 A member of the Committee may resign from their position at any time.
- 4.7 Members are encouraged to attend all meetings of the Committee. If a member fails to attend three consecutive meetings of the Committee without obtaining a leave of absence that member shall be deemed to have resigned from the Committee.

5. Frequency of Meetings

Meetings will be held monthly with extra meetings scheduled as required.

5. Quorum

The quorum for a meeting will be no less than a majority of the members appointed to the committee.

7. Reporting

- 7.1. The business of the committee shall be recorded in proper minutes.
- 7.2 Agendas and notes of each meeting will be distributed to all members.
- 7.3 The committee will provide reports on its activities as required.
- 7.4 The Council will be responsible for providing administration support to the Committee.

8. Support

- 8.1. Members agree to provide appropriate support, including:
 - Provide appropriate notice of attendance at meetings.
 - Circulate meeting documentation.
 - Take the minutes for each meeting.
 - Track the decisions of the Committee.
 - Keep appropriate records of the meeting documentation, including the confirmed minutes.

9. Advice to the group

- 9.1. The Committee may invite and obtain expert advice as required.
- 9.2. Any formal advice requested by the committee will be made available to all Committee members and, where relevant and appropriate, will be provided to the Council through meeting minutes.

10. Review of Terms of Reference

- 10.1 The Benalla Indoor Recreation Centre Project Steering Committee Terms of Reference will be reviewed in 2026.
- 10.2 The Committee's terms of reference may be reviewed at any time by the Council to accommodate changes in legislation, regulations, policy gaps, new technology or systems, as well as remain consistent with industry best practice.
- 10.3 The Council shall consult with the Committee prior to amending the Committees terms of reference.

PURPOSE OF REPORT

The report presents for consideration the draft *Fair Access Policy*.

BACKGROUND

In 2020, the Victorian State Government passed the *Gender Equality Act* which is designed to improve workplace gender equality in the Victorian Public Sector. As the level of government closest to the community, Victorian Councils have a mandate to create healthy, safe, and inclusive communities.

The Fair Access Policy Roadmap is an Australia-first policy that aims to give women and girls better and fairer access to community sports and recreation infrastructure. Developed by the Office for Women in Sport and Recreation in partnership with VicHealth and Sport and Recreation Victoria, the policy requires all Victorian local government authorities (LGAs) to have in place a gender equitable access and use policy (or equivalent) by 1 July 2024 to remain eligible for state government community sports infrastructure funding.

The development of the draft Fair Access Policy (refer **Appendix 1**) has been achieved through support from The Office for Women in Sport and Recreation, who have provided policy templates, hosted workshops, and shared resources. Council staff have adapted the templates provided to suit the context of Benalla Rural City.

DISCUSSION

The draft *Fair Access Policy* seeks to address known barriers experienced by women and girls in accessing and using community sports infrastructure and applies to community sports infrastructure where the Council is the land manager and/or operator of the facility.

The draft *Fair Access Policy* aims to progressively build capacity and capabilities of the Council in the identification, and elimination of systemic causes of gender inequality in policy, programs, communications, and delivery of services in relation to community sports infrastructure.

The draft *Fair Access Policy* and subsequent action plan, provide the framework for the Council to undertake the necessary and proportionate steps to improve access and participation to sports and recreation opportunities for women and girls in Benalla Rural City.

The policy has been created in accordance with Council's Administration Policy *Management Guidelines Policy*.

The policy was presented to the Council's Leadership Team at its March 2024 meeting.

Policy Objective

The Fair Access Policy (the Policy) seeks to address known barriers experienced by women and girls in accessing and using community sports infrastructure.

The Policy aims to progressively build capacity and capabilities of Benalla Rural City Council (the Council) in the identification, and elimination of systemic causes of gender inequality in policy, programs, communications, and delivery of services in relation to community sports infrastructure.

Benalla Rural City Council will undertake take the necessary and proportionate steps towards implementation of the Fair Access Policy.

Background

Sport is a highly visible and valued feature of Benalla Rural City's culture and identity. The sport and active recreation sector provide opportunities for enriching our communities through the promotion of respect and fair mindedness for all people, while also supporting the physical and mental wellbeing of all Victorians.

The Council is well positioned to design and implement place-based, integrated actions plans that progress gender equality in community sport.

The Victorian Government is committed to developing an environment for all Victorians to live in a safe and equal society, have access to equal power, resources, and opportunities, and are treated with dignity, respect, and fairness.

A reform agenda has been developed to change the systems that have perpetuated gender inequality by designing an enduring structure that requires implementation and tracking of progress over time.

This reform agenda includes addressing the traditional structures and way community sport and recreation organisations operate through the implementation all nine recommendations from the 2015 Inquiry into Women and Girls in Sport and Active Recreation. This includes recommendation six:

"...encourage facility owners and managers to review access and usage policies to ensure women and girls have a fair share of access to the highest quality facilities at the best and most popular times"

and

"facilitating a universal adoption of [policies, strategies and audit tools] will drive change further"

As a defined entity of the *Gender Equality Act 2020*, the Council will be required from 31 March 2021 to conduct *Gender Impact Assessments* (GIA) on all new policies, programs, communications, and services, including those up for review, which directly and significantly impact the public.

The access and use of community sports infrastructure is an example of policy that has a direct and significant impact on the public.

Statement of Intent

This Statement of Intent establishes the expectation that gender equality is considered and prioritised in all current and future planning, policy, service delivery and practice as they relate to community sports infrastructure.

- a. Benalla Rural City Council recognises that gender equality is the attainment of equal rights, responsibilities, and opportunities of women, men, trans and gender diverse people. Equality does not mean that women, men, trans and gender diverse people will become the same but that their rights, responsibilities, and opportunities will not depend on their gender.
- b. Benalla Rural City Council recognises that gender equity is the provision of fairness and justice in the distribution of benefits and responsibilities based on gender. The concept recognises that people may have different needs and power related to their gender and these differences should be identified and addressed in a manner that rectifies gender related imbalances.

Policy Scope

The Policy enables effective and efficient integration of the requirements of the *Gender Equality Act 2020*, the *Local Government Act 2020* and the *Public Health and Wellbeing Act 2008* and other legislative frameworks.

The scope of the Policy is to support the Council to take positive action towards achieving gender equity in the access and usage of community sports infrastructure.

This complies with the Gender Equality Act 2020 and aligns with Municipal Public Health and Wellbeing Plans or Council Strategies:

To support Benalla Rural City Council to take positive action towards achieving gender equity in the access and use of community sports infrastructure	To build capacity and capabilities of Benalla Rural City Council in the identification and elimination of systemic causes of gender inequality in policy, programs, communications, and delivery of services in relation to community sport and recreation. To ensure an effective place-based response for the gender equitable use and access of community sports infrastructure. To promote gender equality in policies, programs, communications, and services as they relate to community sports infrastructure.

For Benalla Rural City Council, the Policy applies to community sports infrastructure with Council being the land manager and/or operator of the facility.

Policy Framework

The Policy is designed to comply with the Gender Equality Act 2020, and the wider Victorian Government gender equality strategy.

Benalla Rural City Council acknowledges:

- a. the disadvantaged position some individuals have had in the sport and recreation sector because of their gender; and
- b. that achieving gender equality will require diverse approaches for women, men, trans and gender diverse people to achieve similar outcomes for people of all genders.

Benalla Rural City Council will:


- engage fairly and equitably with all staff, governance working groups, state sporting organisations, regional sport assemblies (where applicable) and members of our sport and recreation community, regardless of their gender, in a positive, respectful, and constructive manner; and
- 2. engage in the process of gender impact assessments to assess the implications for women, men, trans and gender diverse people of any planned action, including policies and communications. This is a strategy for making all voices, concerns and experiences, an integral dimension of the design, implementation, monitoring of policies and programs.

Fair Access Principles

The Fair Access Principles have been developed by the Office for Women in Sport and Recreation, Sport and Recreation Victoria and VicHealth, in consultation with representatives from local government and the state sport and recreation sector.

This Policy and any resultant action plan are based on six principles of inclusivity, full participation, equal representation, encouraging and supporting user groups, and prioritising user groups committed to equality.

The Council considers that these principles provide clear direction, while also enabling adaption to the specific environment of Benalla Rural City.



Compliance and Monitoring

a. Actions

The Council commits to undertake a GIA on all current community sports infrastructure access and use policies and processes, and to consider opportunities to strengthen gender equitable access and use of community sports facilities in alignment with the Fair Access Principles.

If the process of assessing current policies and processes identifies opportunities to develop or strengthen gender equitable access and use of community sports facilities in alignment with the Fair Access Principles. The Council commits to developing and adopting a locally relevant gender equitable access and use policy and action plan no later than 1 October 2024.

The Council acknowledges that the requirement to have a gender equitable access and use policy and action plan (or equivalent) in place, and the ability to demonstrate progress against that policy and action plan (or equivalent), will form part of the eligibility criteria for Victorian Government funding programs relating to community sports infrastructure from 1 July 2024.

The Council has also identified specific actions to progress gender equitable access and use of community sports infrastructure in its Fair Access Action Plan.

b. Responsibility

The General Manager Corporate is responsible for implementing the Council's Fair Access Policy. Management personnel, staff, volunteers, and stakeholders (for example SSAs and RSAs) at the Council have a shared responsibility to support the policy, as outlined below.

- To promote a gender-aware and gender-responsive culture and community and championing the Fair Access Policy.
- To promote, encourage and facilitate the achievement of gender equality and improvement in the status of women and girls in sport and active recreation.
- Lead the review of sport and recreation policies and process
- Develop and adopt gender equitable access and use policies
- To communicate policy updates to all staff and members
- To monitor compliance and issues
- To promote, encourage and facilitate the achievement of gender equality and improvement in the status of women and girls
- Support the undertaking of Gender Impact Assessment and submission of progress reports as per the Gender Equality Act 2020 obligations
- Support the review of sport and recreation policies and processes
- Support the formal adoption process of a new or revised gender equitable policies
- Undertake Gender Impact Assessment and submission of progress reports as per the Gender Equality Act 2020 obligations
- To communicate and educate sport and recreation infrastructure user groups and users.
- To adhere to and communicate the policy when required.
- To attend training / awareness programs.

Definitions

Committees of Management

For the purposes of this document, refers to committees appointed by the Department of Land, Water, Environment and Planning under the *Crown Land (Reserves) Act 1978* to manage recreation reserves where community sport training and games are held.

Community Asset Committees

For the purposes of this document, refers to committees appointed by Council under the Local Government Act 2020 to manage recreation reserves where community sports infrastructure is located and utilised for community sport activities.

Community Sports Infrastructure

Publicly owned local, rural, regional, or state level sport and recreation infrastructure operated and maintained primarily for the purpose of facilitating community sport activities, including sporting grounds, surfaces, facilities, and pavilions.

Gender

How you understand who you are and how you interact with other people. Many people understand their gender as being a man or woman. Some people understand their gender as a mix of these or neither. A person's gender and their expression of their gender can be shown in different ways, such as through behaviour or physical appearance.

Gender diverse

An umbrella term for a range of genders expressed in different ways. Gender diverse people use many terms to describe themselves. Language in this area is dynamic, particularly among young people, who are more likely to describe themselves as non-binary.

Gender equality

The equal rights, responsibilities and opportunities of women, men and trans and genderdiverse people. Equality does not mean that women, men and trans and gender diverse people will become the same but that their rights, responsibilities, and opportunities will not depend on their gender.

Gender equity

The provision of fairness and justice in the distribution of benefits and responsibilities based on gender. The concept recognises that people may have different needs and power related to their gender and these differences should be identified and addressed in a manner that rectifies gender related imbalances.

Gender Impact Assessment, or GIA

A requirement under the *Gender Equality Act 2020* to be carried out on policies, programs and services which have a direct and significant impact on the public. The assessment must evaluate the effects that a policy, program or service may have on people of different genders.

Public land management groups

For the purposes of this document, are the Committees of Management appointed under the *Crown Land (Reserves) Act 1978* and responsible for the management of recreation reserves where community sport training and games are held.

Transgender, or trans

Someone whose gender does not only algin with the one assigned at birth. Not all trans people will use this term to describe themselves.
