10. Reports by Councillors

Cr King gave a statement regarding the Council Meeting on 27 October 2021. Cr King's statement was as follows:

My fellow Councillor, Cr Gunaratne, has raised concerns about points I made regarding the Long Term Financial Plan.

First and foremost, I would like to be clear that when I made my comments, I never intended to make any personal criticisms of Cr Gunaratne in any way. I have the highest regard for what he and my fellow councillors bring to the table to represent our community. I will always encourage robust debate, however, I have now had the opportunity to reflect with Cr Gunarante and explore his concerns.

Without being specific, I have come to realise that elements of my speech had a negative impact on Cr Gunarante and possibly others. I would like to take this opportunity to say for those unintended impacts, I am sincerely sorry. I want to be clear that Cr Gunarante, along with my fellow Councillors, was actively and passionately involved in the development of the Long Term Financial Plan from start to finish.

I want to reinforce that while I may not agree with some of the arguments made on the night, Cr Gunaratne's questions and comments were appropriate advocacy for the final moment before we voted on the topic.

Ultimately that's what we are here to do, advocate passionately for our community and finalise discussions.

Punar and I have otherwise resolved his concerns privately and I thank him for that resolution. Together Punar and I take this moment to confirm our appreciation for the efforts by the staff, CEO and our Council colleagues in achieving the Long Term Financial Plan.

I close by maintaining that I feel very confident that this council will continue to work together and deliver great outcomes to the people of Benalla Rural City.

Cr Gunaratne acknowledged Cr King's statement.



Cr King reported on the Benalla Sporting and Community Group Summit Project. At the Council Meeting on 10 February 2021 the Council passed a motion to host a community and sporting group summit to understand the impacts of COVID-19. Since passing the motion the CEO and Cr King have meet with Council staff to continue to develop a framework for the project. The Summit will be conducted via a data type survey collection and community engagement with sporting community groups, clubs, presidents and chairpersons. The CEO has been in communication with Valley Sport who are undertaking a similar project. Community groups and clubs are encouraged to participate in the survey data collection. A detailed report will be developed from the data collected.

Cr Firth reported that he attended the Benalla Youth Services Provides Network (BYSPN) meeting via zoom on 17 February 2022. The Benalla Rural City Council was successful in acquiring a three year grant to help provide youth services to the community. The grant will support the continuation of youth events and services like successful Live4Life program.

Cr Gunaratne reported that he visited a subdivision in Wodonga on 9 February 2022 with Landscape Architect Susan Campbell OAM. Ms Campbell was a Project Manager for the subdivision. The subdivision featured changing terrains, ponds, underground cycling, walking paths and artificial mountains to reduce noise. To acknowledge the successful work of Susan Campbell a reserve located on the hill between Willow rise and the Yarralumla Drive housing estate has been named the Susan Campbell Reserve. He noted that sustainable housing subdivisions have been raised as a concern within the Community Plan Implementation Steering Committee. The Committee believes there is a great opportunity to learn from other sustainable housing subdivisions within the region. Ms Campbell has expressed interest in facilitating sustainable landscaping designs within Benalla Rural City.

Cr Claridge reported that the Friends of BPACC Committee has decided to fund a small theatre season with money raised through fundraisers. On the 11 February 2022 *The Burt Bacharach Songbook* was live at BPACC with Wendy Stapleton. The night was well received by all who attended. *The Traveling Wilburys* (tribute band), *Songs of Bernadette Robinson* and *David Hobson* live music events are scheduled for 8 March 2022, 29 April 2022 and 18 June 2022. A Morning Music Show is being considered for early June with a Tom Jones theme. The Committee are spending approximately \$50,000 on the live music shows. The Friends of BPACC were established in 2005 and have fundraised for BPACC and have supplied ushers and bar staff to help run the facility.
