### 1. Public Question Time

It is recorded that Andrea Wymond tabled a question regarding the *Benalla Indoor Recreation Centre Redevelopment Project*.

Has a gender impact assessment been done for the Benalla Indoor Recreation Centre redevelopment with respect to facilities at the current BIRC site at Ackerly Avenue, Benalla?

The Acting Chief Executive Officer answered that no gender impact assessment has been completed. A gender impact assessment will be completed for any new facilities that are developed.

It is recorded that Paul O'Brien tabled a question regarding the *Benalla Indoor Recreation Centre Redevelopment Project*.

Current advertising material by the Council states that planning for the Benalla Indoor Recreation Centre has progress. To what stage has it progressed?

The Acting Chief Executive Officer answered that schematic designs are currently being considered. Existing services survey and geotechnical investigations for the Barkly Street site have also been completed.

To date what is the monetary cost Council has spent on construction, plan reports and all other works for the BIRC Redevelopment project?

The Acting Chief Executive Officer answered that expenditure to date including investigation, planning and design work for the *Benalla Indoor Recreation Centre Redevelopment Project* is \$168,587.

Has the Council received firm notification that they will definitely be able to have property at the Barkly Street Site to build the new indoor stadium?

The Acting Chief Executive Officer answered that no notification has been received. Negotiations with the State Government regarding the site at Barkly Street, Benalla continue.

When will the Council release the results of the second online survey concerning BIRC which was conducted in September 2024?

The Acting Chief Executive Officer answered that the objective of the survey was to assist architects with the design phase for the proposed Benalla Indoor Recreation Centre at Barkley Street, Benalla. Survey results will be posted on Council's website.

- 3. When authorised by the Minister for Planning, exhibit Amendment C45bena to the Benalla Planning Scheme in accordance with the Minister's instructions and conditions.
