I have asked to suspend standing orders tonight to advise councillors and those at home, of my intent to resign from the Council after tonight's meeting.

This decision follows my acceptance of a position as an Electorate Officer with Annabelle Cleeland MP.

In accordance with the Local Government Act 2020, I'm unable to hold both positions simultaneously and therefore must resign from my position as Councillor.

Serving as a Councillor has been one of the greatest honours of my life, being elected as the youngest Councillor in Benalla Rural City has been both a privilege and a responsibility that I've taken with immense pride.

It's provided me with an invaluable insight into governance, community leadership and the workings of local government and it has deepened my commitment to public service.

Throughout my term, although short, I have greatly valued the opportunity to represent the community and contribute to projects and initiatives that support the social and economic wellbeing of Benalla and its residents.

Working alongside my fellow councillors, council officers and members of the community has been an inspiring experience that has strengthened my belief in the power of collaboration and civic engagement.

Whilst it is difficult to step away from this role, my decision to accept a position as an electorate officer represents a continuation of my commitment to public service.

The new role will allow me to embed myself more deeply in the political sphere and continue advocating for the people of our region, albeit in a different capacity.

I see it as an opportunity to build upon what I've learned in local government and to contribute more broadly to the policies and initiatives that shape the future of rural and regional Victoria.

I want to extend my sincere gratitude to my fellow councillors, council staff and the Benalla community for their trust, encouragement and collaboration throughout my time on council.

I'm proud of what we have achieved together and remain deeply committed to supporting the ongoing success of Benalla Rural City.
