1. Public Question Time

Why has the Council, for Confidential Business of Council Meeting 6 August 2025, and for each Item, ignored the requirements of the Local Government Act Section 66 (5) (a) and (b) to record in the Minutes the grounds for determining to close the meeting to Confidential Business and can it now comply? (a) the ground or grounds for determining to close the meeting to the public by reference to the grounds specified in the definition of confidential information in section 3(1); and (b) an explanation of why the specified ground or grounds applied.

The Chief Executive Officer answered that Council has complied to the regulation with the following general statement in the meeting agenda:

“It is proposed that the following items be considered in confidential business pursuant to the *Local Government Act 2020* as they contain personal information or private commercial information that would result in the unreasonable disclosure of information about a person, their personal affairs or expose the business, commercial or financial undertaking if released”.

However, your question has led to a review of our compliance under the *Local Government Act 2020*, and consideration of best practice. This review has identified opportunities to strengthen Council’s approach to confidential matters to improve transparency to the community.

To strengthen Council’s approach, we have implemented the inclusion of specifically reasoning for each item to be confidential in nature. This can be seen in our Council meeting agenda dated 19 November 2025.

Under Section 26 of the Act, before the election of the Mayor, the Council must determine by resolution whether the Mayor is to be elected for a one-year or a two-year term.
